1. The Democratic Socialist Republic of Sri Lanka has applied for financing from the Asian Development Bank (ADB) toward the cost of Power System Reliability Strengthening Project (PSRSP). Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.

2. Ceylon Electricity Board (CEB), (“the Employer”), invites sealed bids from eligible bidders for the,

Matara – Hambanthota (77 km), Hambanthota – Thissamaharama (23 km),
Homagama GSS to Horana – Padukka Line (8 km)
Baddegama GSS to Ambalangoda – Galle Line (0.5 km)
Cable Termination Tower at Kelaniya for UG cable termination of Peliyagoda GSS

Completion period is 730 days (from the Contract Effective Date).

3. International Competitive Bidding (ICB) will be conducted in accordance with ADB’s Single-Stage: Two-Envelope bidding procedure and is open to all bidders from eligible source countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

- Bidders are required to have satisfactory experience as contractor, JV Partner or subcontractor, in at least three (3) contracts within the last ten (10) years, each with a value of at least US\$ 18 million that have been successfully or substantially completed and that are similar to the proposed contract. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section 6 (Employer’s Requirements) of the bidding document.
- Bidder shall have minimum average annual turnover of at least US\$ 25 million, calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.

(Note: Only important eligibility criteria are mentioned above briefly. To know the complete eligibility criteria, intending bidders are advised to inspect the Bidding Document by visiting the website of Ceylon Electricity Board, www.ceb.lk.)

- Visit the office of the Project Manager (PMU2) at address indicated above between 09:00 hours and 15:00 hours on working days until the bid submission deadline and pay a non-refundable fee of LKR 20,000.00 by cash or in the form of bank draft written in favor of the General Manager, Ceylon Electricity Board, Colombo, Sri Lanka.

- Request for delivery by sending a written application to the address above requesting the bidding documents for **“Procurement of Plant – Design, Supply and Installation of Package 2 Lot ‘A’ of PSRSP, Construction of 132kV Transmission Lines”**. The application must include a bank draft in favor of the General Manager, Ceylon Electricity Board, for the amount of LKR 25,000.00 (domestic delivery) or US\$ 300 (Overseas delivery). The document will be sent through courier. No liability will be accepted for loss or late delivery.

The site visit for Homagama Linewill be held on the same day at 14:00 hours. Site visit for Baddegama, Matara – Hambanthota& Thissamaharama Lines will be held on 5 and 6 November2020.

Late Bids shall be rejected.

Technical bids will be opened on 9 December 2020 at 10:15 hours (local time) in the presence of Bidders’ representatives who choose to attend at the Office of the AGM (Projects), Ceylon Electricity Board, 4th Floor, No.385, Land Mark Building, Galle Road, Colombo 03, Sri Lanka, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after Technical Bid Evaluation, whereas, the Financial Bids of those Bidders whose Technical Bids are not responsive and qualified shall be returned unopened after the contract is awarded.

9. When comparing Bids, ADB’s Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the Bidding Document.

10. The Employer will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation, attending Pre-Bid meeting, site visits and delivery of Bids.
