- 1. The Chairman, Board Procurement Committee on behalf of the CEYLON ELECTRICITY BOARD hereby invites sealed bids from eligible and qualified Bidders for the Procurement of Works, Conductor Upgrading of Mannar Vavuniya 220 kV Transmission Line Package 12 as described below.
- 2. Time for completion of the Works in 546 days
- 3. Bidding will be conducted through the International Competitive Bidding (ICB) Procedure.
- 4. To be eligible for contract award, the successful Bidder shall not have been blacklisted and shall meet the following requirements;

For local bidders;

Grade	:	C2 and above and EM1
Expiry date	:	The CIDA registration shall be valid for at least up to three months from the bid closing

For Foreign bidders;

When notified must obtain CIDA Registration before the Award of Contract, the registration fee shall be 0.01% of the contract sum

5. Qualification requirements to qualify for contract award include:

- Participation in the 132 kV or above transmission Lines construction including stringing works of 132 kV or above Transmission Lines as a Main Contractor, Management Contractor, JV partner, or Subcontractor in at least three (03) contracts that have been successfully or substantially completed within the last ten (10) years and that are similar to the proposed works, where the value of the Bidder's participation of each contract exceeds LKR 450 million (US\$ 1.5 million).
- Minimum average annual construction turnover (should be verified in the audited accounts) of LKR 760 million (USD 2.38 million), calculated as total certified payments received for contracts in progress or completed, within the last 5 years.
- The Bidder must demonstrate access to, or availability of, liquid assets, lines of credit, or other financial resources (other than any contractual advance payments) to meet the Bidder's financial resources requirements in Form QIF-3 in the bidding document. The financial resources requirement for this procurement shall be at least LKR 95 million (USD 0.3 million).

- 10. All bids shall be accompanied by a Bid-Security of LKR 10 million or US\$ 35,000. Bid Security shall be valid up to a minimum of 28 days beyond the validity of Bid.
